2. The concept and construction status of curriculum ideology and politics

The greater the resistance, the greater the partial voltage, the greater the capacity, the greater the responsibility. Students' spirit of dare to undertake and contribute are cultivated.

(2) Triode current distribution relationship and the characteristics of small current control large current, small signal control large signal. Through the characteristics of triode small signal control large signal, students understand the truth of "four ounces dial a thousand pounds", and can bring great impact to the system by changing or controlling some small links in production practice.

(3) Principle and characteristics of triode multistage amplifier circuit. Multistage amplifier circuit is divided into input stage, intermediate stage and output stage. The role of the input stage is to increase the input resistance of the amplifier circuit, the role of the intermediate stage is to amplify the voltage, and the role of the output stage is to reduce the output resistance. Through the indispensable role of each level of the amplifier circuit in the triode multistage amplifier circuit, students understand the importance of cooperation between various departments and everyone in the team, and cultivate the spirit of cooperation among students.

(4) Master the basic operation of domestic EDA (Li Chuang) software. By comparing the gap between domestic EDA and international EDA software, students can understand the power of science and technology, set lofty goals, and work hard for Industry 4.0 and Made in China 2025.

3.3 Reshape the teaching goals and innovate teaching design

After the introduction of curriculum ideology and politics, it will inevitably have related influence on the original curriculum teaching. Teachers first need to reshape their teaching goals. A class is no longer only about knowledge and ability goals, but also about improving students' quality goals. While teaching knowledge, students are guided to form a complete and correct three views, and are cultivated students' hard work style. Innovating teaching design under the guidance

For example, online-offline hybrid teaching models extend traditional classrooms through the development of information technology, and use platforms to record students' learning trajectory, and can also feedback issues and results in real time to cultivate students' spirit of excellence. Various virtual software simulation operations have expanded students 'practical platforms, enhanced students' hands-on ability, visualized abstract problems, and helped students understand experimental principles and methods. Through the method of flipped classroom, students' self-learning ability and independent thinking ability have been exercised. The students are allowed to feel the practical difficulties that may face the future career path in advance and to find how to solve it. Through the project-based team cooperation model, students' division of labor and cooperation and teamwork can be cultivated.

After the introduction of curriculum ideology and politics, students' learning effects can be also detected through new evaluation methods. For example, we can take the work order as a carrier, adopt the whole process evaluation and multiple evaluation to evaluate the learning effect of students.
