3. Specific Measures to Integrate Ideological and Political Education in Professional Courses

On the one hand, with the development of the teaching practice of "course ideology and politics", teachers' awareness will continue to improve. The ideological and political content should be adjusted in time according to the actual effect. Through the accumulation of teaching practice, practical cases can be used as elements of ideological and political, it can more resonate with students; on the other hand, the ideological and political content itself is dynamic, with the development of the times [5], new concepts, new theories and ideas will continue to emerge and become indispensable ideological and political content.

3.3 Approaches and Implementation Strategies for Integrating Ideological and Political Education into Professional Teaching

In the teaching process, it is necessary to integrate the educational goals into the teaching goals according to the provisions of the program of training talents. Adhere to the educational requirements into the whole process of teaching work, design the teaching content, and scientifically and reasonably design the content, time, method and so on according to the characteristics of knowledge and the laws of teaching and educating people[6]. The ideological and political education should be integrated with professional knowledge in flexible and changeable forms, so as to realize the organic unity of education and knowledge imparting, and achieves the effect of moisturizing and educating people silently.

3.3.1 Find the ideological and political points that fit with professional knowledge

Through systematic curriculum design, we can establish generative internal fit relationship in the way of organic mutual integration, so as to achieve "genetic" integration. The integration of ideological and political content into professional knowledge should follow the principle of combining" ideological and political" with "professional", make clear the entry point of each ideological and political element, and clarify the relationship between ideological and political elements and professional content. First, from the traditional teacher-centered teaching method to the student-centered task-based teaching method. In the teaching process of professional courses, teachers can arrange tasks to explore ideological and political elements related to the professional content, and complete corresponding tasks in groups. In this learning mode, students carry out learning activities with tasks, their autonomy is enhanced, and the learning effect is more obvious.

Second, case teaching method to strengthen interaction. In classroom teaching, through typical cases, students are inspired to think about the value orientation reflected behind them, and the teaching interaction is strengthened in the teaching process, allowing students to talk about their own feelings and understanding, highlighting focus on learning and enhance students' sense of participation.

Third, using audio-visual and oral teaching methods. The teaching method emphasizes the overall perception, audio-visual use, it is help to improve students' interest and enthusiasm. Teachers should avoid "filling the classroom" and "cramming" teaching, make full use of audio-visual materials, and vividly display ideological and political content to students to enhance their educational significance and persuasive power.

3.4 Improve the Evaluation Mechanism of Curriculum Ideological and Political

The effect of talent training is the primary criterion for the evaluation of curriculum ideological and political construction. Whether the ideological and political development of the curriculum is effective, whether there are bright spots and shortcomings, a sound and scientific evaluation mechanism is needed. Therefore, it is necessary to innovate the curriculum evaluation system, break the traditional examination-based evaluation system, and combine the school's "three-in-one" assessment. In addition to knowledge and skills, the evaluation system must comprehensively consider the performance of students in political and moral education.

Adhere to goal orientation and problem orientation, proceed from reality, and test ideological and political education with actual results. Whether students are actively receiving or passively instilling, whether they have gained something or is meaningless, has become the main guide for evaluating the success of the course's ideological and political practice.Establish students as evaluation subject, and the subject of evaluation is no longer solely borne by teachers, students evaluate themselves and each other, which reflects the subject status of students' learning and evaluation[7]. In addition, through questionnaires, discussions, etc., students can be ideologically improved on whether they have improved their awareness of active learning, independent thinking, innovative thinking, positive attitude, awareness of cooperation and communication, scientific rigor, and a realistic style, whether they love their jobs, etc. aspects are evaluated. According to the evaluation results, reflect on the teaching process, better improve the design and implementation of course ideological and political education, build a cyclic system of teaching and diagnostic evaluation, and achieve the general goal of building virtue and cultivating people.
