2. The integrated development path of ideological and political education and emergency management under the 4R theory

2.1 Reduction stage: the daily ideological and political education occupies a dominant position

Once someone 's negative thoughts are widely echoed, it is easy to form negative public opinion, which has a negative impact on social order and social atmosphere. Because personal emotions and mentality have a great correlation with the social atmosphere at this stage. In order to create a positive anti-epidemic and overcome the difficult social atmosphere, the ideological and political education at this time needs to return to the social individual, with the goal of soothing and boosting the people. Therefore, appeasing people 's emotions is the primary work, so that they can quickly regain confidence and lay the foundation for mobilizing people to actively participate in epidemic prevention and control in the later period. In addition, it is necessary to identify the key objects, classify and group psychological comfort, which is conducive to suit the remedy to the case, timely adjust and dredge the counseling personnel and ideological obstacles and psychological conflicts, and guide them to get out of the psychological shadow in time.

Everyone 's cognition is the same, and the cognitive difference is not only related to the danger brought by the thing itself, but also related to the individual 's values and cognitive mechanism of danger. Medical and health institutions should give full play to the professional functions of handling, preventing and preventing sudden public health events. On this basis, they should increase the publicity and education of public health related knowledge, and then correct the cognitive bias of a small number of people, so that the general public can correctly understand the source of public health risks and specific preventive measures. In addition, in addition to dealing with the crisis of special public health events, medical and health institutions also undertake the treatment of other diseases. The idea of medical and preventive integration should be firmly embedded in the process of treatment of other diseases, and integrate public health education with medical assistance. This is not only a manifestation of improving the people 's ability to save themselves and help each other, but also a means to guide them to establish correct values.

2.4 The acute ideological and political education and daily ideological and political education gradually integrated

In the response stage of the public health crisis, the medical staff, regardless of their own lives and the people, immediately rushed to the front line of the fight against the epidemic. They use action to write a hymn worth people to learn, is the most close to the masses of the hero model. At this time of crisis education and example will be more exemplary, social responsibility is more rendering. The ideological and political education in the new era should make full use of this vivid teaching material. On the one hand, the heroic deeds should influence people's cognition of medical work, understand the special dangerous nature of medical work, affect the trend of doctor and patient relationship on the other hand, promote the benign development of doctor and patient relationship in the future. Combining the recessive education and the explicit education also widely enhances the social responsibility of the general public.

We can not ignore the establishment of emergency ideological and political education evaluation mechanism has a direct role in promoting the recovery and reconstruction stage of public health crisis. The evaluation of ideological and political education is the best means to solve the social sequelae in the later stage of public health crisis management. Through the investigation and analysis of the public 's ideological dynamics and the development trend of social mentality in the later stage of crisis, the humanistic care and psychological counseling can be carried out in a targeted manner. Therefore, the evaluation mechanism of emergency ideological and political

education is constructed, which is implemented to each prevention and control subject, and emphasizes that the evaluation mechanism runs through the whole process of crisis management. Only in this way can ideological and political education be perfectly integrated with the emergency management system, and play a guiding role in dealing with the next public health crisis, thus enhancing the predictability of public health emergency management.

3. Conclusion
